#### **PREFACE**

The 2011 edition of the *Monroe County Governmental Officials List* is provided as a service to local residents by the League of Women Voters of Bloomington-Monroe County. This annually updated booklet includes the names and addresses of elected and appointed officials, citizen membership on boards and commissions, and meeting times and other appropriate information.

In updating the Officials List, the League tries to be current and accurate. Information for this booklet was collected in March and April 2011. Some positions remain unfilled, and the terms of some members listed here in this booklet expired. It is the policy of most boards and commissions to have members serve until they are replaced or reappointed. In addition, during the year, changes occur in personnel and in meeting times and places. We encourage you to verify any required information with the appropriate office.

This booklet contains several additions and changes. The City of Bloomington Commission on Aging, created in December 2009, is listed for the first time, and the Bloomington Arts Commission has been restructured. The city also added a communications director. Monroe County added a grants administrator position, which is listed under the County Administrator department. The Monroe County Human Rights Commission, founded in December 2010, is listed for the first time. In April 2011 the South Central Community Action Program restructured its board, reducing its number from 21 to 15, a change reflected in this list.

We are dedicating this booklet to the memory of Natalie Wrubel, who, for more than 20 years, single-handedly managed every aspect of its preparation and publication. Natalie, a League member since 1952, died Nov. 5 at the age of 85. We miss her.

District I: Bloomington Township precincts 2, 6, and 14\*; Perry Township precincts 1\*, 2\*, 3, 4\*, and 5; Richland Township precinct 9; and Van Buren Township precinct 2.

District II: Bloomington Township precincts 7, 13, 14\*, and 17.

District III: Bloomington Township precincts 8, 9, 10, 11\*, and 16; and Perry Township precincts 20, 21, and 22\*.

District IV: Bloomington Township precinct 5; and Perry Township precincts 14, 15, 16, 17, 18, 19, and 22\*.

District V: Perry Township precincts 6, 8, 9, 10\*, 11\*, 12, 13, and 23\*.

District VI: Bloomington Township precincts 1, 3, and 4: and Perry Township precinct 7.

Bloomington precinct 14 and Perry precinct 22 are each split between two Council districts.

\*denotes a precinct split between City and County. Only voters in the incorporated area may vote in City elections. Their polling place is located in a neighboring City precinct.
