District II: Bloomington Township precincts 7, 13, 14\*, and 17.

District III: Bloomington Township precincts 8, 9, 10, and 16; and Perry Township precincts 20 and 21.

District IV: Bloomington Township precinct 5; and Perry Township precincts 14, 15, 16, 17, 18, 19, and 21.

District V: Perry Township precincts 6, 8, 9, 10\*, 11\*, 12, and 13.

District VI: Bloomington Township precincts 1, 3, and 4; and Perry Township precinct 7.

\*denotes a County precinct, part of which has been annexed by the City. Only voters in the incorporated area may vote in City elections. Their polling place is located in a neighboring City precinct.
